

INFORMATION ON THE GRANT OF THE TRANSFORMABLE AND EXTENDABLE VISA

Documents needed:

- 2 Forms to be filled and signed by the applicant
- 2 passport photographs
- Return ticket or booking confirmation from the Travel Agency
- Valid passport (at least 6 months)
- Criminal Record Check : valid less than 3months

If Employed:

- Work permit issued by the “Ministère du Travail” (Ministry of labour)
- Attestation of employment (Work certificate in Madagascar)
- Carte d’identité fiscale (Card with the number of Fiscal identity)
- ID card copy

If Scientist or Researcher

- Authorization of research issued by the Ministry of Scientific research or Education (Ministère de l’Enseignement Supérieur et de la Recherche Scientifique)

If Investors

a) Company

- Status of the Company
- Bank statement issued by a local bank
- Registration certificate from the “Registre du Commerce”
- Attestation of an application for a professional card
- CNFI

b) If running a company

- Bank statement
- Attestation of an application for a professional card
- Number of Fiscal Identity (numero d’identite fiscale)

c) Student (diploma or a degree)

- Enrolment certificate
- Attestation of entitlement of any scholarship or proof of income
- Proof of accommodation, invitation letter
- Copy of the ID of the accommodation provider

If Retired

- Attestation of retirement
- Proof of a bank account in Madagascar
- Proof of any income or fund
- Proof of any entitlement for benefits from the “Caisse de retraite” or Fees from any retirement funding.

If Trainee

- Letter of invitation from the organization or company providing the training session
- Authorization issued by the Ministry in charge

If a Religious

- Attestation of belonging belief (religious belief and organization)
- Letter of invitation issued by the organization (accommodation, expenses) issued by an official and recognized congregation established in Madagascar
- Copy of the National ID of the person inviting
- Authorization letter if the host is a missionary or congregation

Family reunion

- Certificate of marriage
- Copy of the passport + copy of the visa (residence permit) of the parents, spouses (relatives) already settled in Madagascar
- Birth certificate

If NGO (Non Governmental Organization)

- A copy of the headquarters agreement or Memorandum of Understanding (MOU)

P.S.: The grant of the “one month extendable”

A declaration letter written by the applicant is required for the grant of the “One Month” extendable and changeable to a long stay visa.

If applied in Madagascar , then the “Ministry de l’intérieur” (Home Office) is in charge.
The fee amount is fixed in Madagascar
